Communication regarding the performance of the IMA stock

Following the rapid and substantial decline in IMA's stock price, the Company would like to point out that its results are in line with expectations.

When the half-year figures are approved on 8 August 2014, the Company will again confirm the targets for the year with **revenues** of 850 million euros and **EBITDA** of 127 million euros, thanks to a constant and positive trend in the order intake, again confirmed in the month of July 2014, which provides excellent visibility for the current year.

Established in 1961, IMA is world leader in the design and manufacture of automatic machines for the processing and packaging of pharmaceuticals, cosmetics, tea, coffee and food. The Group has more than 3,600 employees, more than 1,600 of whom overseas, and can count on 24 production plants in Italy, Switzerland, the United Kingdom, the United States, India and China. IMA has an extensive sales network comprising 27 branches which provide sales and service in Italy, France, Switzerland, the United Kingdom, Germany, Austria, Spain, Poland, Israel, Russia, the United States, India, China, Malaysia, Thailand and Brazil, representative offices in Central and East European countries and over 50 agencies covering a total of more than 70 countries. **IMA S.p.A. has been listed on the Milan Stock Exchange since 1995 and in 2001 joined the STAR segment.** The following manufacturing companies are part of the IMA Group: Co.ma.di.s.
